New Business -

- Line-of-Credit renewal Chief Nisbet states it is time again to renew the line
 of credit with Capital Bank (offer attached), renewal fee is \$250 and a 5%
 fixed rate, the same as last year. He adds, "we didn't have to use it last year,
 but it is nice to have, just in case we do need it." Commissioner Ducrou
 moves to adopt Resolution 2018-01 Establishing the Line of Credit.
 Commissioner Cook seconded the motion and with none opposed, motion
 passed.
- Review of the New Impact Fee Study Chief Nisbet states "every five years, Lee County Administration is required to do an impact fee study to ensure the cost of construction meet the current impact fee dollar amounts. This is the study that was just completed by Duncan & Associates. Looking at the rates, our rates go up in some areas almost 63%, but it takes us back to where they were prior to the housing market crash where they started reducing the rates and they did that study and the cost came down, so as of right now, the Board of Commissioners have reviewed it in the workshop, it's supposed to go in front of them in a County Commissioner board meeting on the 20th, and they're going to recommend holding off on doing any implementation for 6 months, because they want to see if there's another methodology out there that they are not using. Typically, what happens is, if they adopt it, they can set whatever percentage of the impact fees they want to of the impact fees for the county entity, but since we are our own independent government agency, they usually just fund ours at 100% of whatever the cost is that is associated and you can make adjustments at that point that you want to. But, more or less for your review, and your opportunity to take a look at it, I just wanted to make sure you have a copy of it. Commissioner Cook asks for confirmation this is what we e-mailed him the other day. It is. With no other discussion offered, Vice-Chairman Griffin calls for anything in New business. Hearing none, he calls for Chief Items.

Chief Items – Chief Nisbet states he has one..."we do have the AFG Grant in for portable radios, I'm not predicting anything yeah or nay in the short term future, but previously you have given me authorization to accept the grant if we do get an acceptance. We did put in for 19 radios to take us up to a dual band 800mhz radio that meets the P25 new technology requirements for where our new systems are going to, and our match would be 5% which would be \$6,329 which is about the cost of 1 portable radio. So, we would get 19 portable radios for the price of 1. So, I would like to get authorization, so if we do receive an award here, that I can go ahead and march on and then bring it back to you at that point. So that way I can get the ball rolling with FEMA if we're lucky enough to get awarded." Commissioner Ducrou moves to provide authorization. Commissioner Cook seconded the motion and with none opposed, motion passed. Chief states he has no other items. Vice-Chairman Griffin calls for Commissioner Items.
